The Integrating & Accessing Care work group is working with UNC Dept. of Emergency Medicine to develop a hospital survey which will go out this month (January 2019). SAC will collect information from each hospital in NC on their stroke services so that we can identify hospitals that need technical assistance and training on stroke diagnosis and treatment. The Prevention work group and an ad hoc committee have worked with the DPH CCCPH branch to develop a Stroke Prevention Campaign which will run in the northeast region of the state beginning in March. The committee is working to identify local resources for those who see the campaign ads and are moved to get more physical activity, eat healthy food, monitor blood pressure, etc. We are updating the Start With Your Heart website with additional resources. See Peg's presentation on the website for additional activities by work group.  SAC will develop a Stroke Systems of Care Plan in 2019 to guide us as we align and act on our work. The goal is to link communities and health systems with prevention, sustainability and increased capacity in stroke care.
