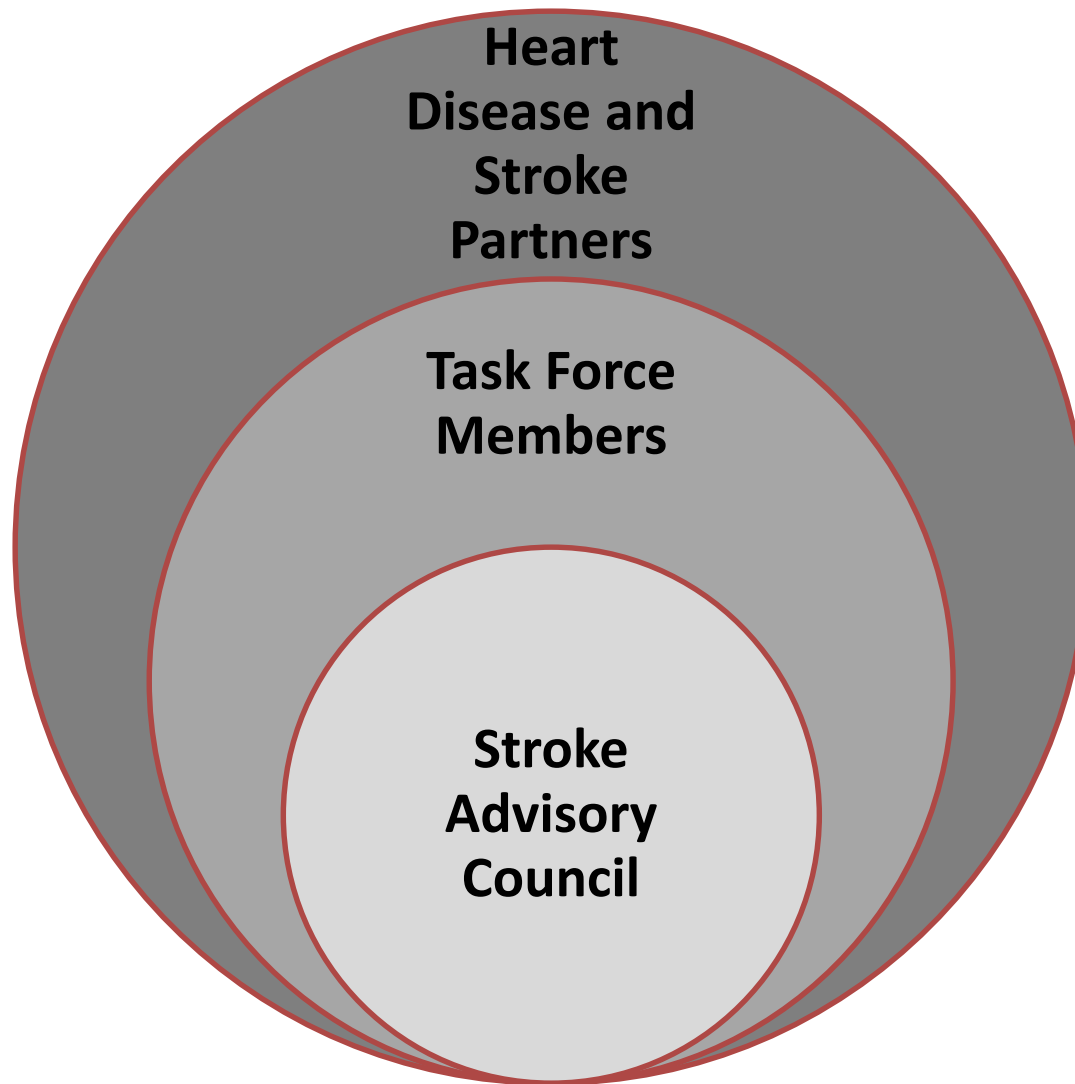

Duties of the Task Force

N.C. G.S. 143B-216.60

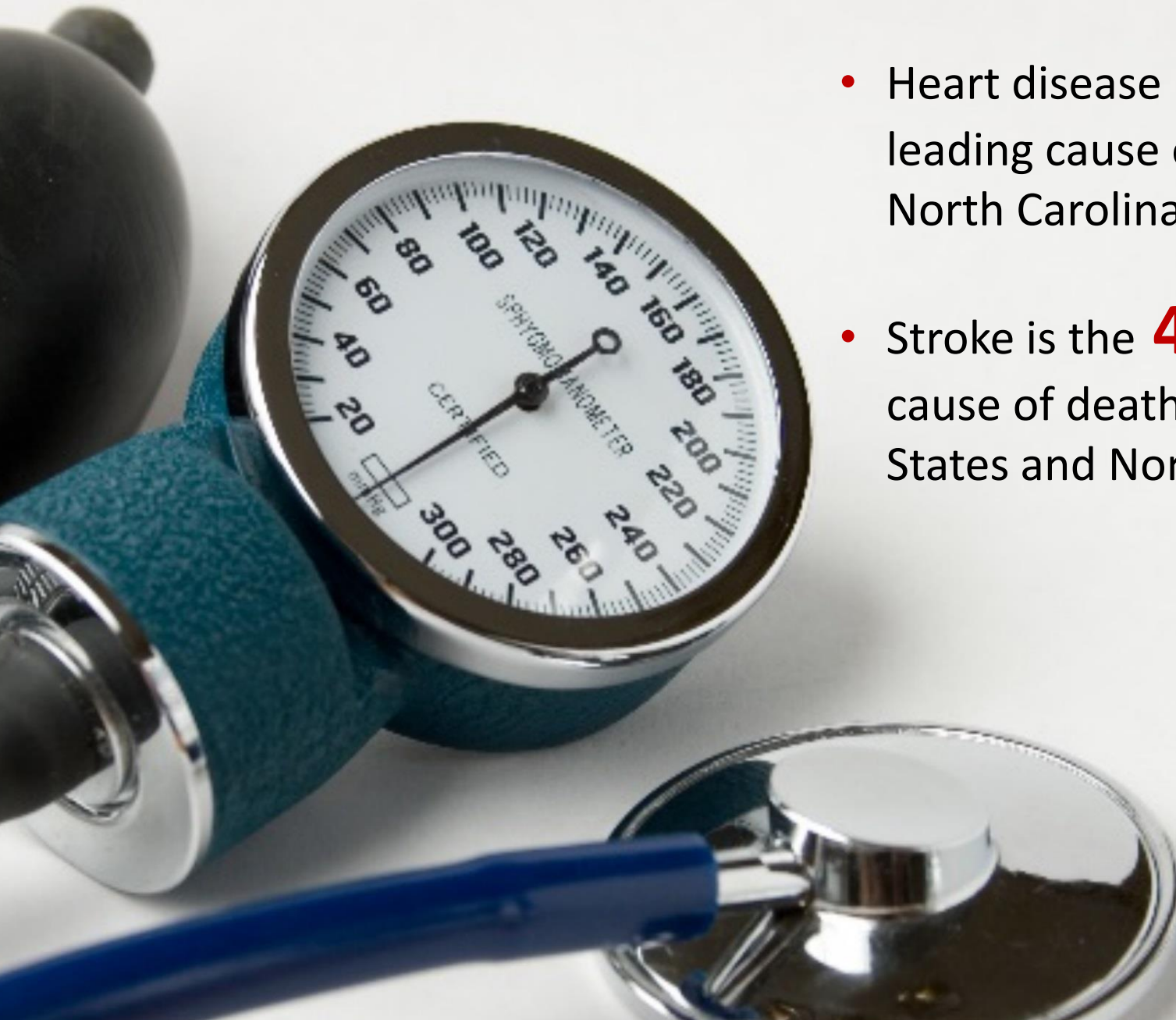
- 1. Establish a profile of the burden** of heart disease and stroke deaths and risks.
- 2. Publicize the profile** of the burden and its preventability.
- 3. Identify priority strategies** effective in preventing and controlling risks.
- 4. Recommend** to the Governor and the General Assembly **changes to existing laws, regulations, programs, services, and policies.**
- 5. Recommend the funding and strategies** needed to **enact new or to modify existing laws, etc.**

Duties of the Task Force

- 6. Adopt and promote** a statewide Heart Disease and Stroke Prevention Plan.
- 7. Facilitate specific commitments** to help implement the Plan.
- 8. Facilitate coordination of and communication** among organizations to achieve the aims of the Plan.
- 9. Consider reports and testimony** from individuals, local health departments and organizations, etc. to learn about their contributions to heart disease and stroke prevention.
- 10. Establish and maintain a Stroke Advisory Council** which shall advise the Task Force regarding the development of a statewide system of stroke care.

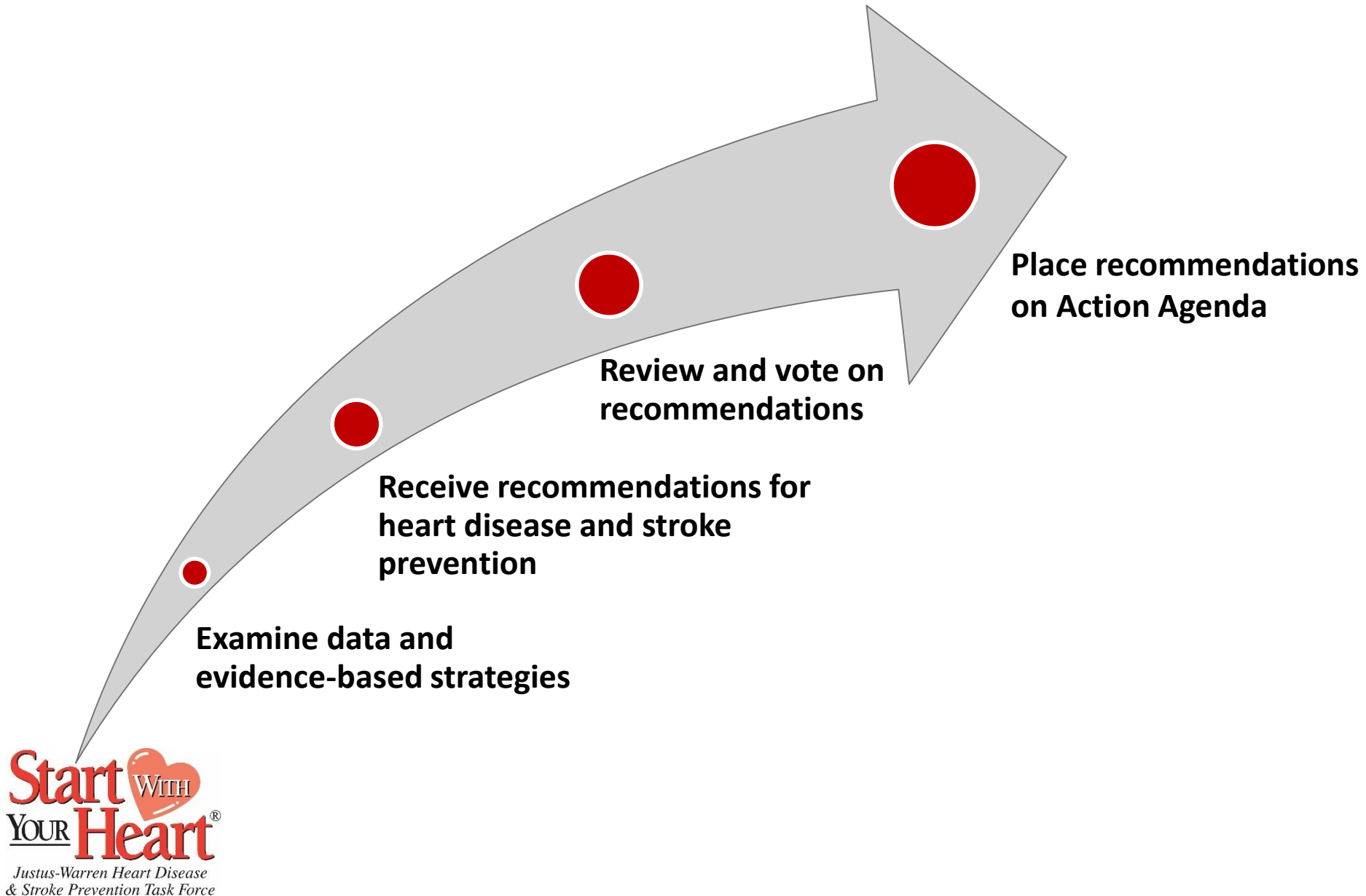
- Heart disease is the **2nd** leading cause of death in North Carolina
- Stroke is the **4th** leading cause of death in the United States and North Carolina



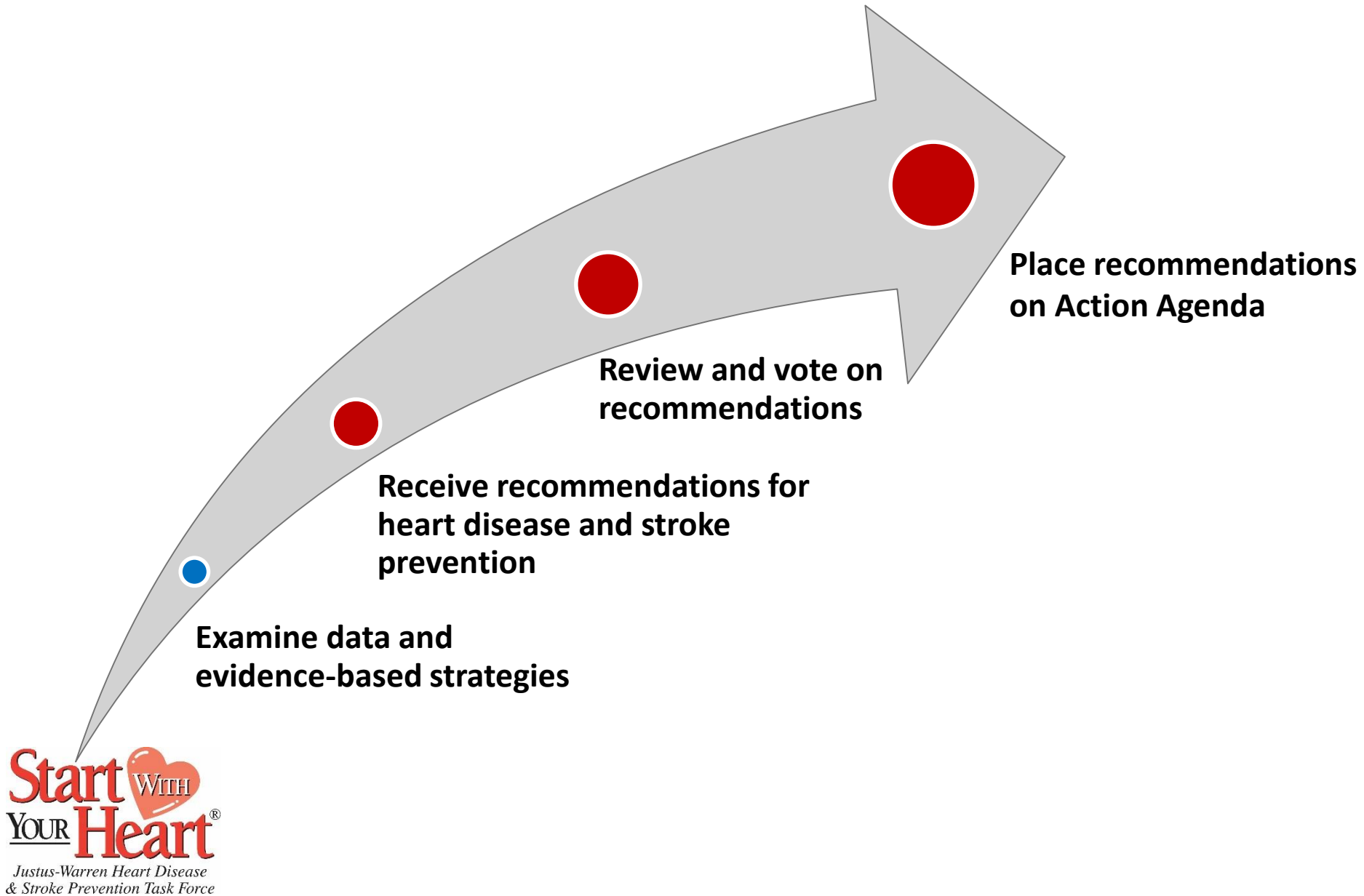

Issue Application for 2016-17

The **Justus-Warren Heart Disease and Stroke Prevention Task Force (JWTF)** is a legislatively appointed task force that makes recommendations to the Governor and General Assembly regarding changes to law and policy in order to prevent and manage heart disease and stroke in North Carolina [N.C. G.S. 143B-216.60].

Through this application process, the JWTF receives requests from groups that would like to propose an evidence-driven issue for JWTF consideration during the 2016-17 meeting cycle. This application will be reviewed by the JWTF Executive Council which may request additional information. If the issue is accepted for JWTF consideration, it will then be examined by appropriate JWTF work groups that will determine which issues to bring to the full JWTF in the form of proposed recommendations. Recommendations approved by the full JWTF become part of the JWTF's annual "Action Agenda."

The goal of the application process is to assure broad access to the JWTF process while also assuring that issues coming before the JWTF are evidence-driven, reflect an appropriate fit with the JWTF mandate, are ripe for consideration, and are of a manageable number.

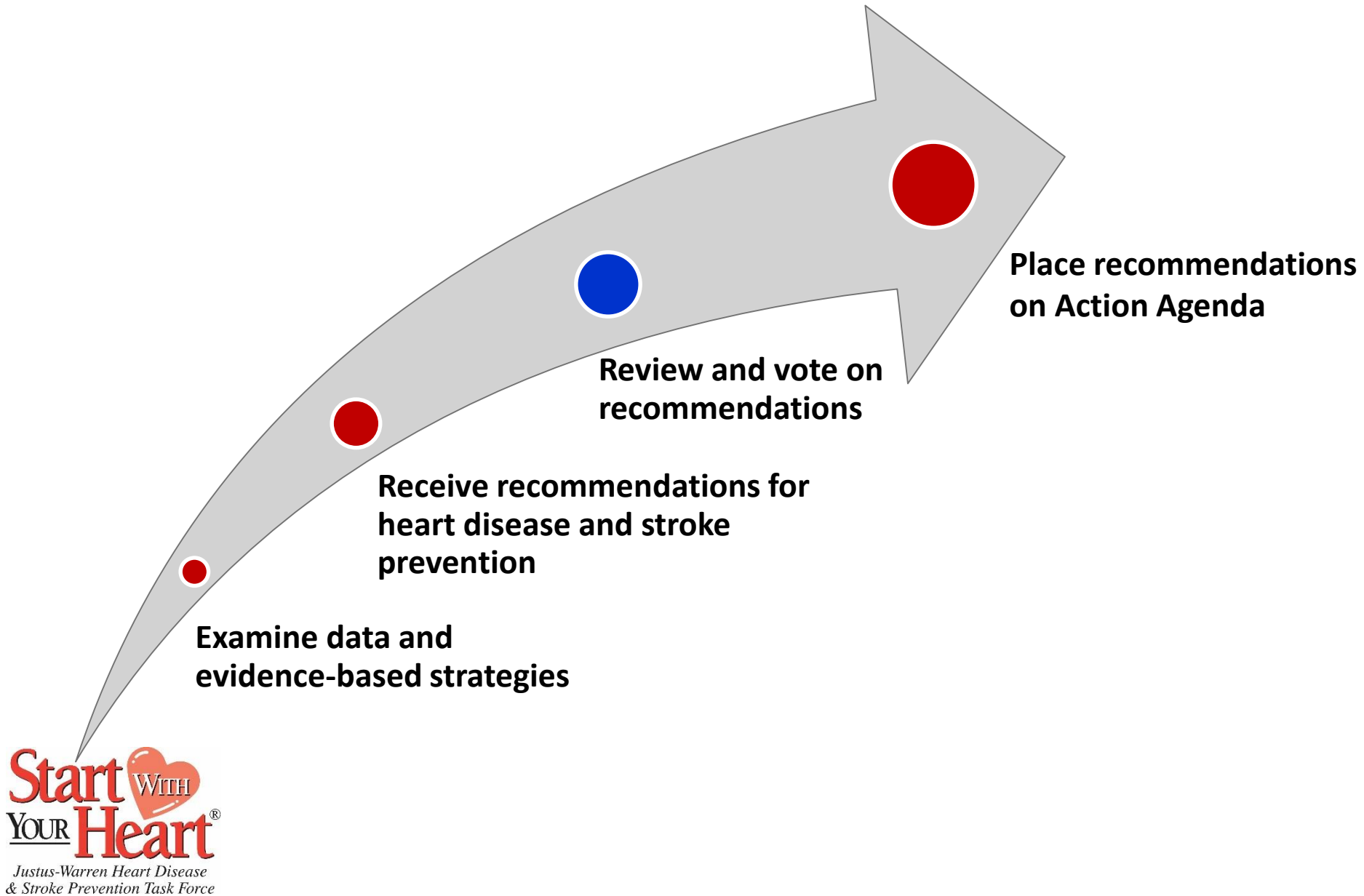
Action Agenda levels of JWTF involvement:

- **Support:** The highest level of involvement is "support" which means that the JWTF takes leadership on advancing the issue.

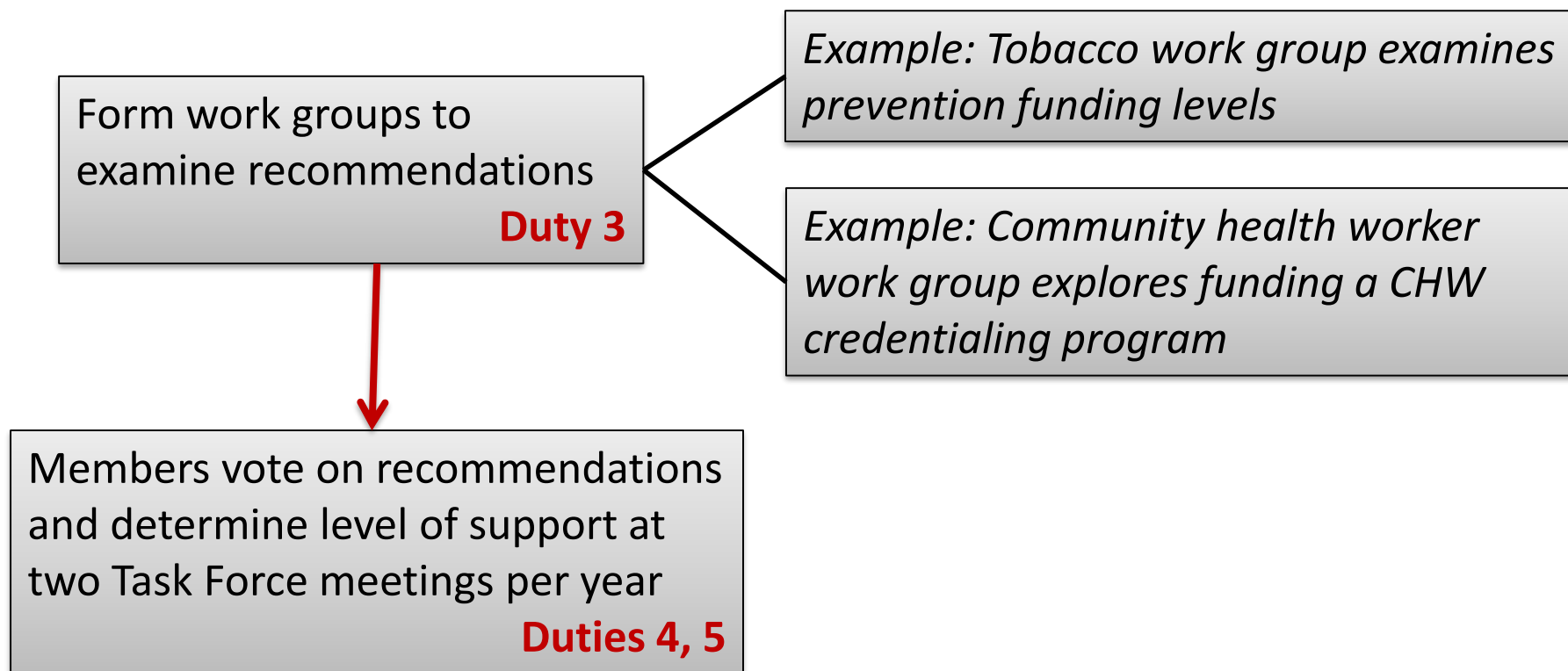

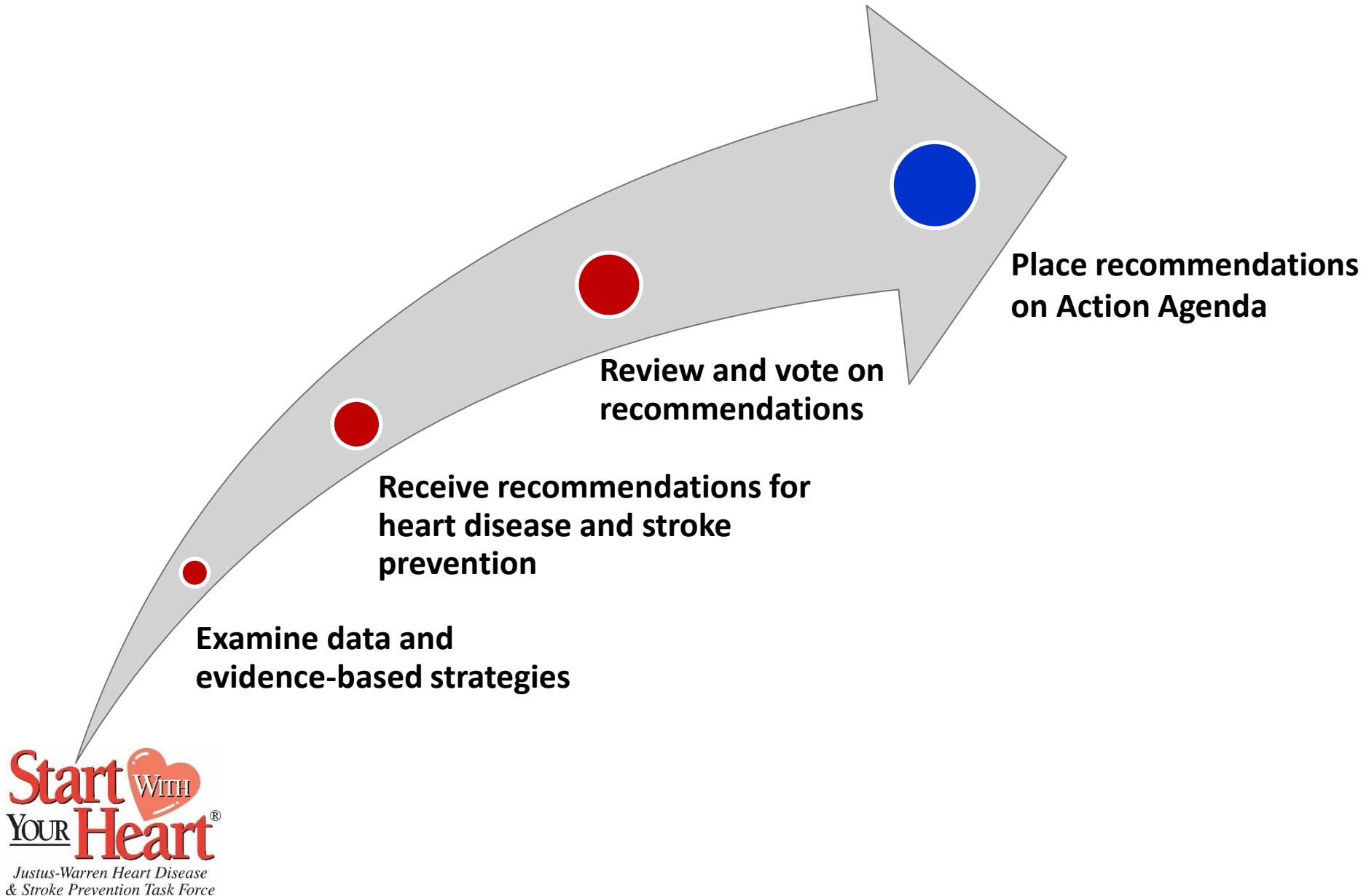

Justus-Warren Task Force Action Agenda 2016-2017 *Sample*

Legislative Endorse

Support increasing the excise tax on tobacco products by \$1.00.

Support \$250,000 in funding to support You Quit Two Quit Program for tobacco cessation and prevention.

Legislative Support

Request \$300,000 to institute a certification program which will provide technical assistance to community health workers and establish a system for reimbursement for their services.

Request funding for community-wide campaigns to increase physical activity.

Administrative

Support enhanced school-based physical education.

Support HUD efforts to make public housing smoke free.

Monitor

Support adequate funding for tobacco cessation and prevention.

Monitor the implementation of federal law requiring e-cigarettes to be classified and treated as tobacco products.

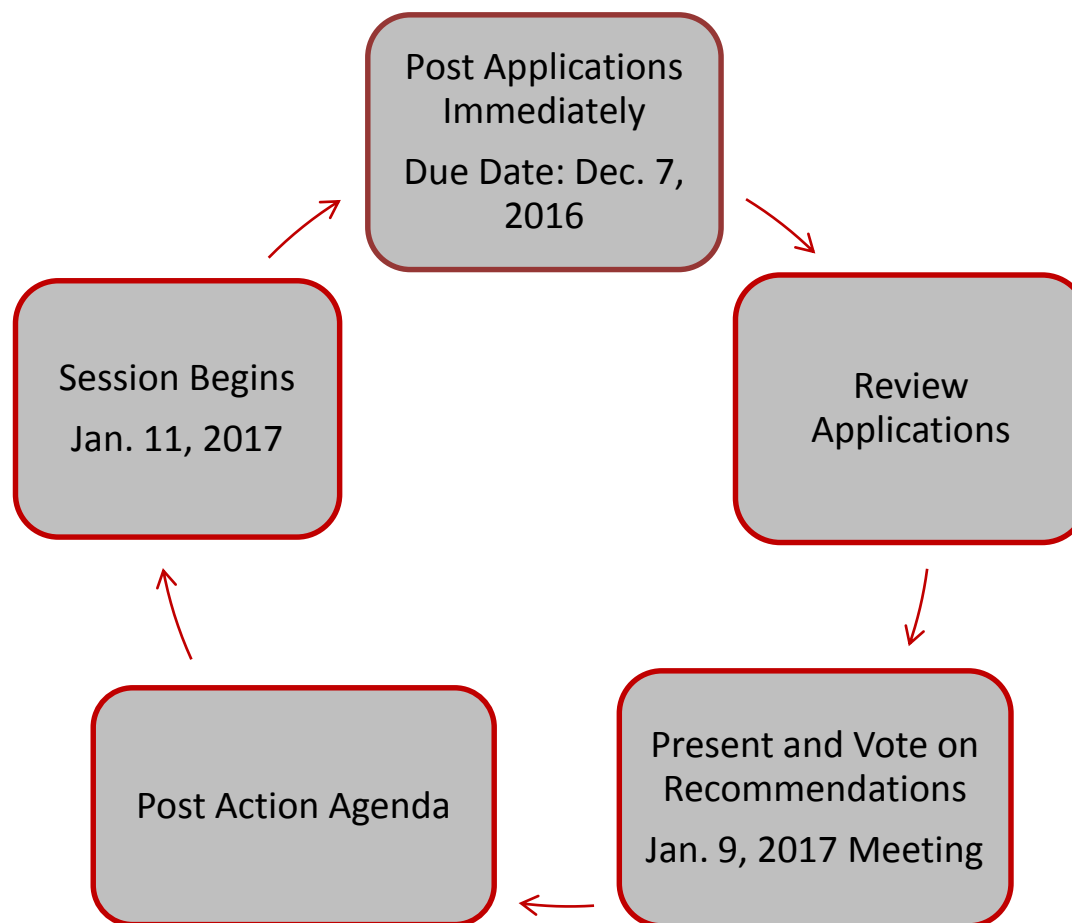
