## Welcome, Introductions

Vice Chair Chuck Tegeler welcomed and thanked all for attending the Stroke Advisory Council meeting on the impact of COVID-19 on Stroke Care in North Carolina.

## Approval of February 26, 2020 Minutes

Due to the shortened meeting format, the February 26, 2020 minutes have been reviewed and approved by members electronically.

#### **Meeting Logistics**

Today we will hear from hospitals about how their stroke services have been impacted by the coronavirus and about adjustments they have made. We will have presentations on Health Equity in COVID-19 and strokes in North Carolina, the Expansion of Telehealth in response to the coronavirus pandemic, changes in stroke system of care, and an update on resources from the American Heart Association.

## **COVID-10 and Stroke Health Equity Perspective**

**Dr. Chere Gregory**, Chief Health Equity Officer and neurointensivist at Novant Health, shared that COVID-19 is the bellwether event that helped us more fully understand the impact of health care disparities. She presented the latest overall COVID-19 mortality rates for Black Americans which is 2.4 times as high as the rate for Whites and 2.2 times as high as the rate for Asians and Latinos. In New Mexico, the Indigenous mortality rate is eight times as high as the White mortality rate. In Arizona, the Indigenous mortality rate is more than five times the rate for all other groups. She shared that there has been a decrease in people with strokes presenting at the ED. See the full presentation.

#### **Expansion of Teleneurology and Telehealth**

**Dr. Amy Guzik**, Director of the Comprehensive Stroke Center and of Telestroke Services at Wake Forest Baptist Health, presented on telehealth expansion from a focus on Telestroke serving 20 hospitals across the state to a broader application of the technology during a pandemic. Advances in telehealth had grown tremendously just before the pandemic hit. Facilities at Wilkes, Davie and Lexington, handled 5-10 tele-consults in June. These consults have helped fine tune and improve workflows of these remote locations. Dr. Guzik shared barriers to video visits and patient and provider satisfaction data. An important next step is to determine how we can support continued reimbursement following the pandemic. See the full presentation.

#### **Changes in Stroke Care**

#### Dr. Ed Jauch, Dr. Alex Schneider, and Robin Jones with Mission Health

Mission Health shared that COVID-19 has forever changed health care and research and presented comparisons of Door to Needle and Door to Groin times pre- and post- COVID-19 onset. COVID screening, intubation protocol and location considerations, and proper PPE have forced changes from parallel action to a necessary step-by-step action progression. There have also been diagnostic delays. Dr. Jauch noted that they have become more comfortable analyzing risk. Robin shared that patient and family are at the center of the Mission model, and COVID has disrupted that. Post-stroke navigation is even more important; yet, many patients refused to go to rehab due to concerns about the virus.

#### Dr. Melanie Blacker with FirstHealth of the Carolinas

Using CDC guidelines and AHA materials, FirstHealth created a public education stroke campaign to encourage those with stroke symptoms to call 911 and get to the ED. All four

FirstHealth sites have telehealth/telestroke options. Discharge planning was beefed up and educational materials were provided including a post-stroke resource for general public available at <u>www.lcareforyourbrain.com</u>
